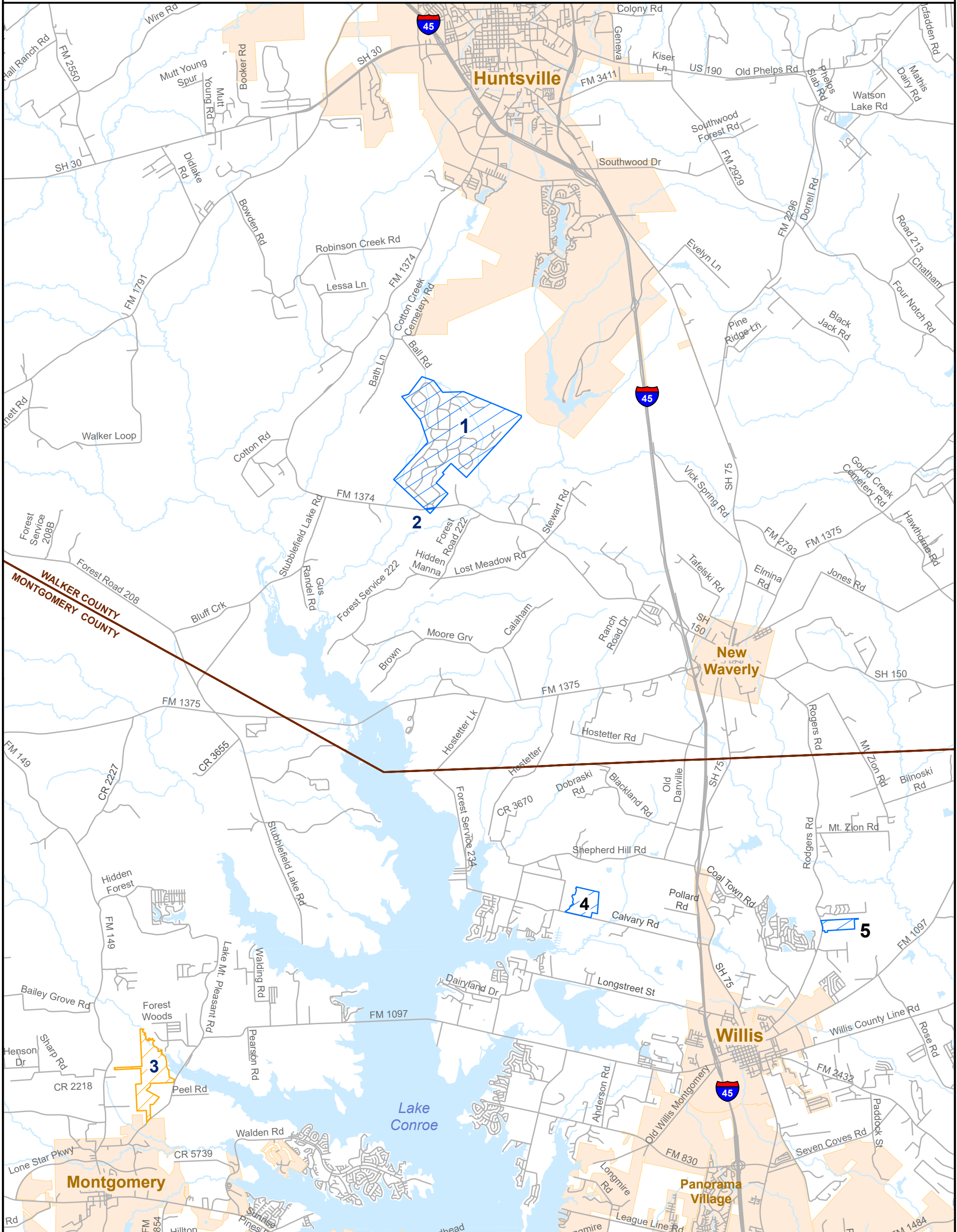
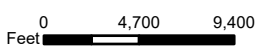

General Location Map #1 - Texas Grand Ranch, Firesong, Rockrose Ranch and Undeveloped Area

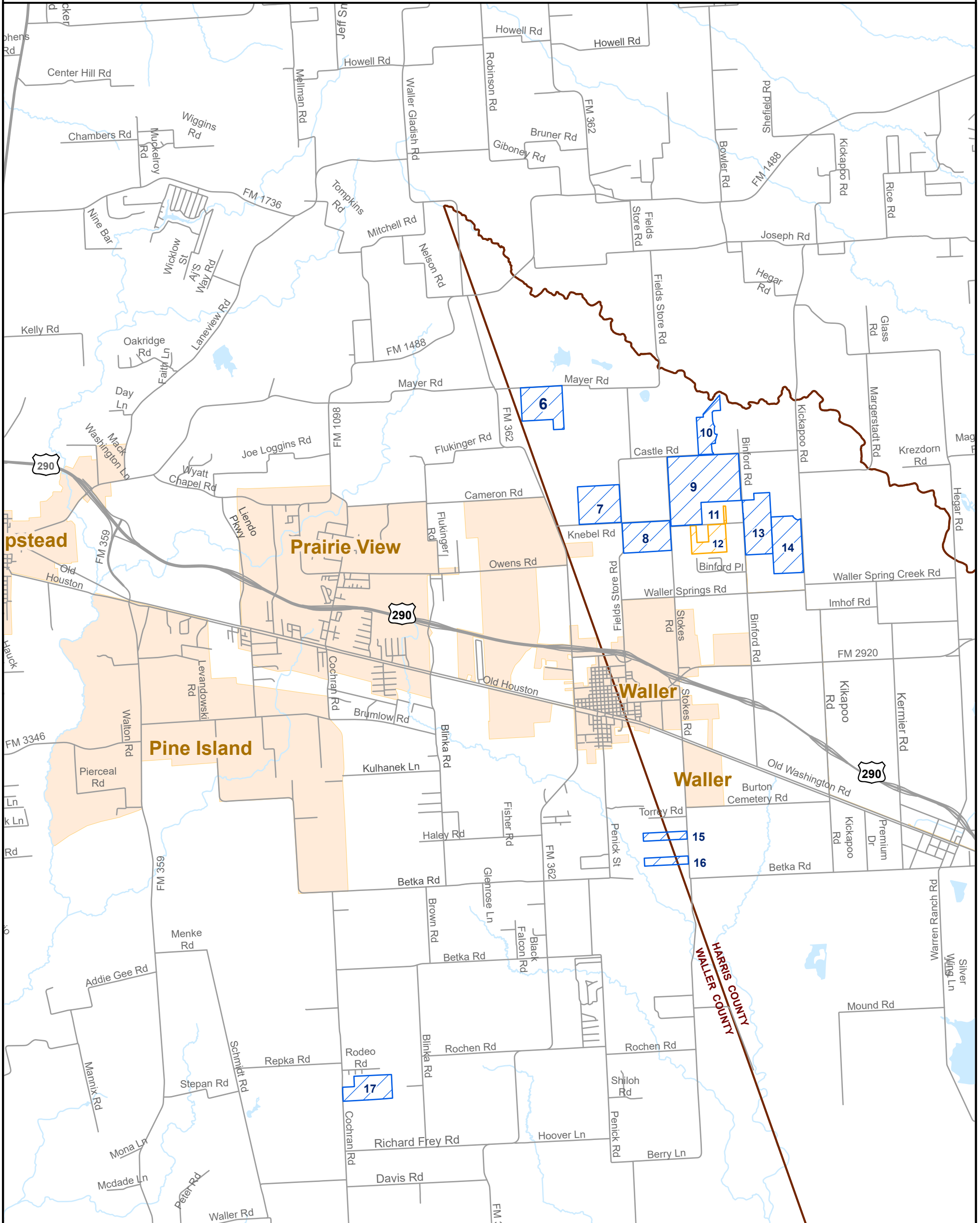

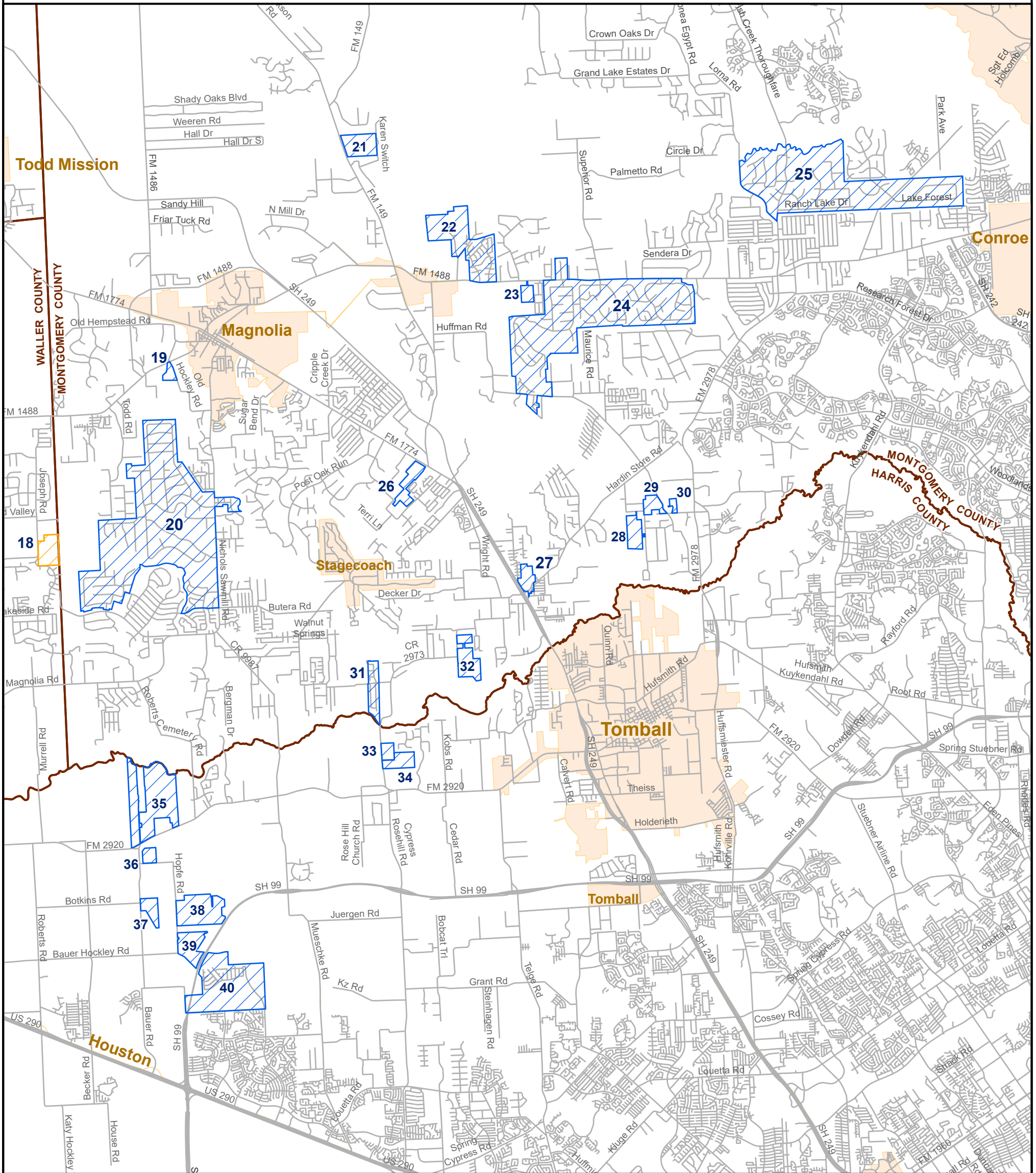

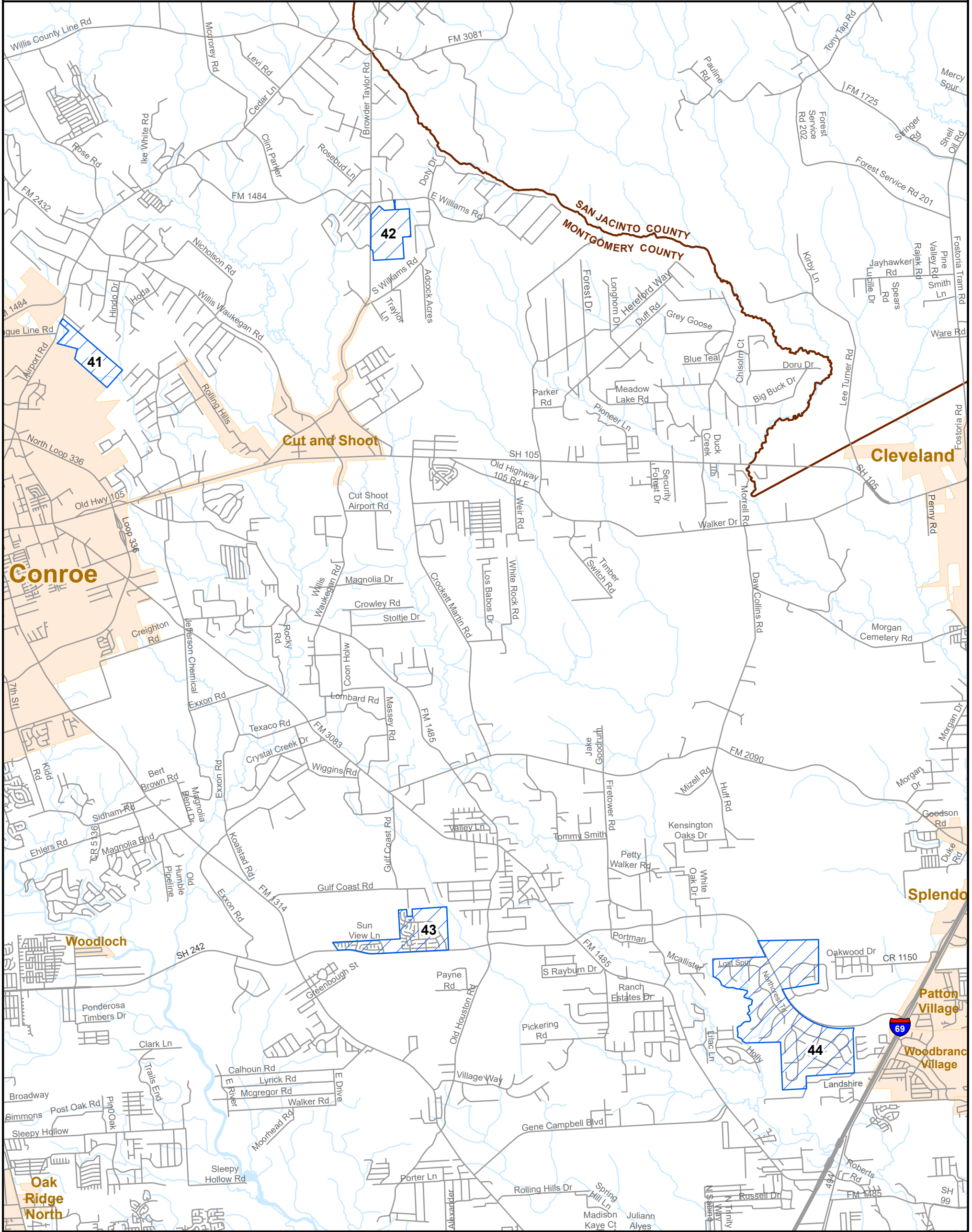

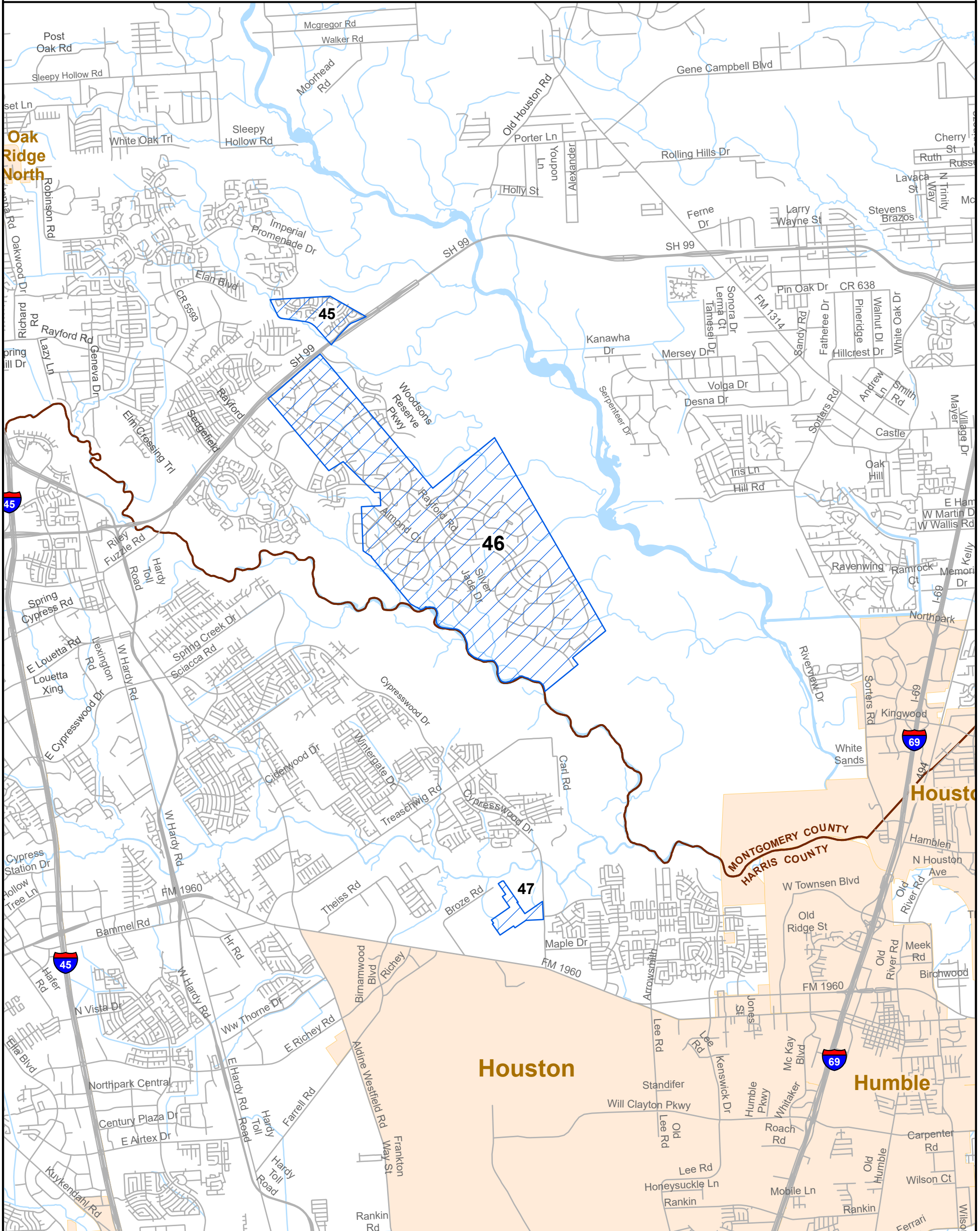

General Location Map #5 - Creekside Village, Benders Landing, Benders Landing Estates and Flagstone

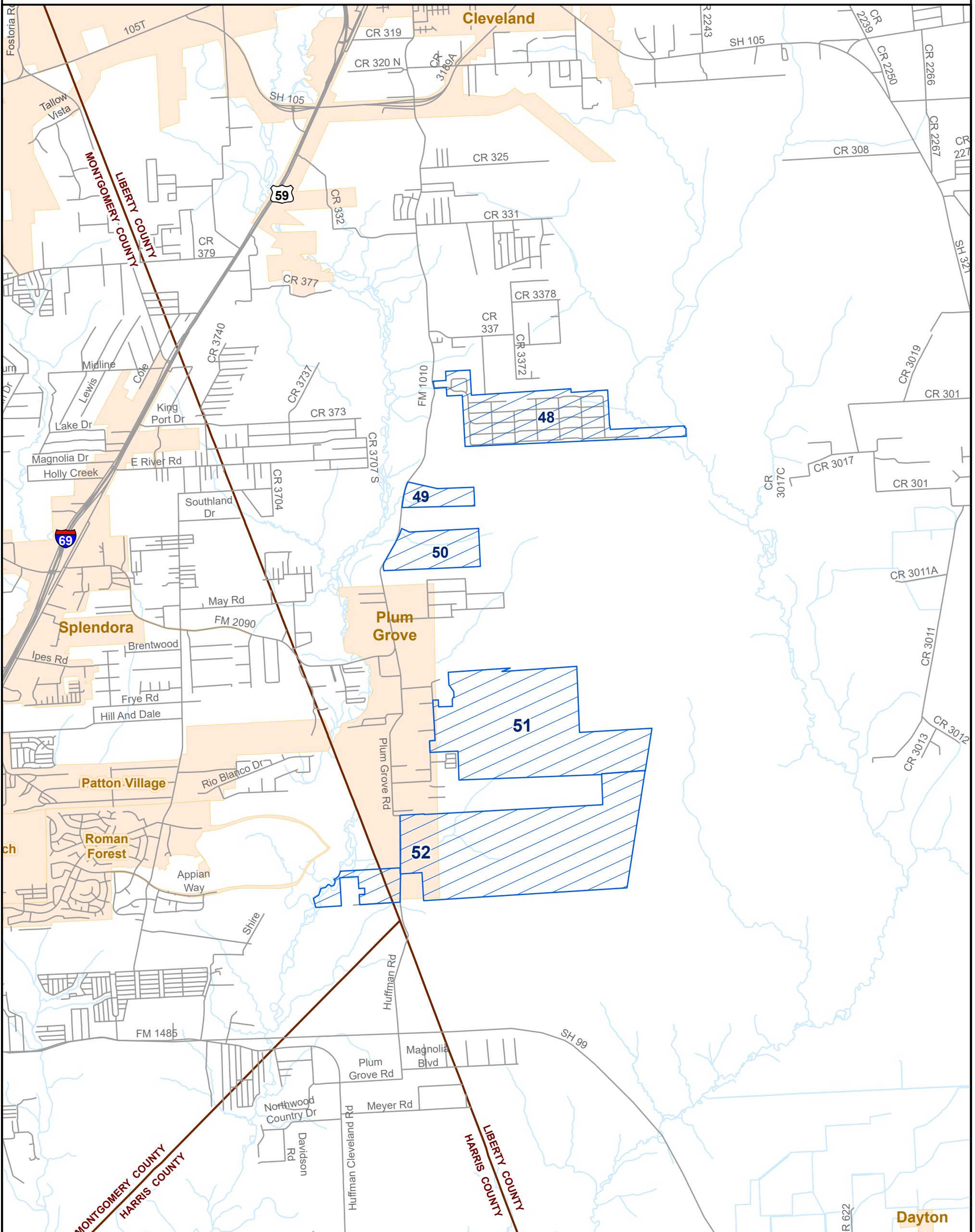

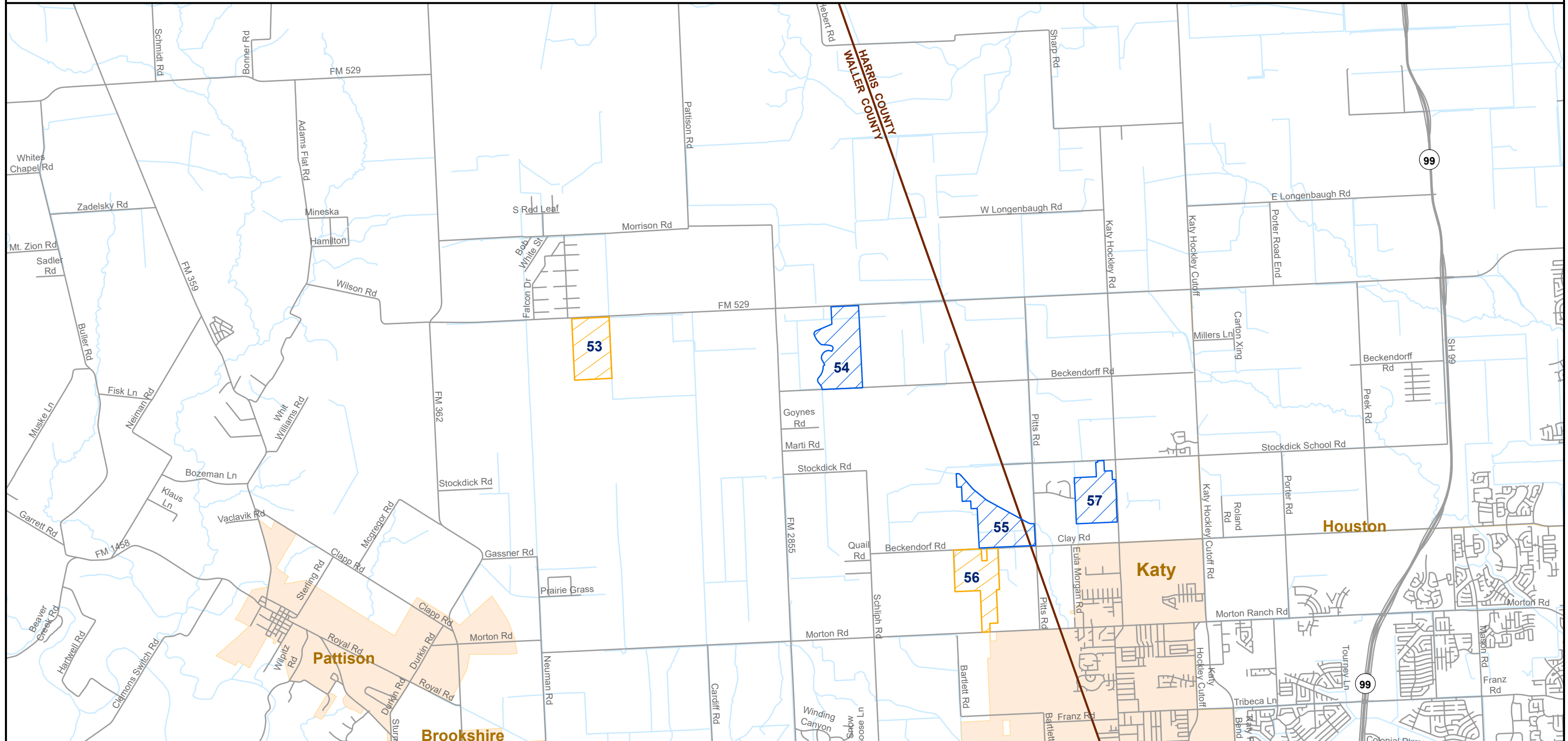

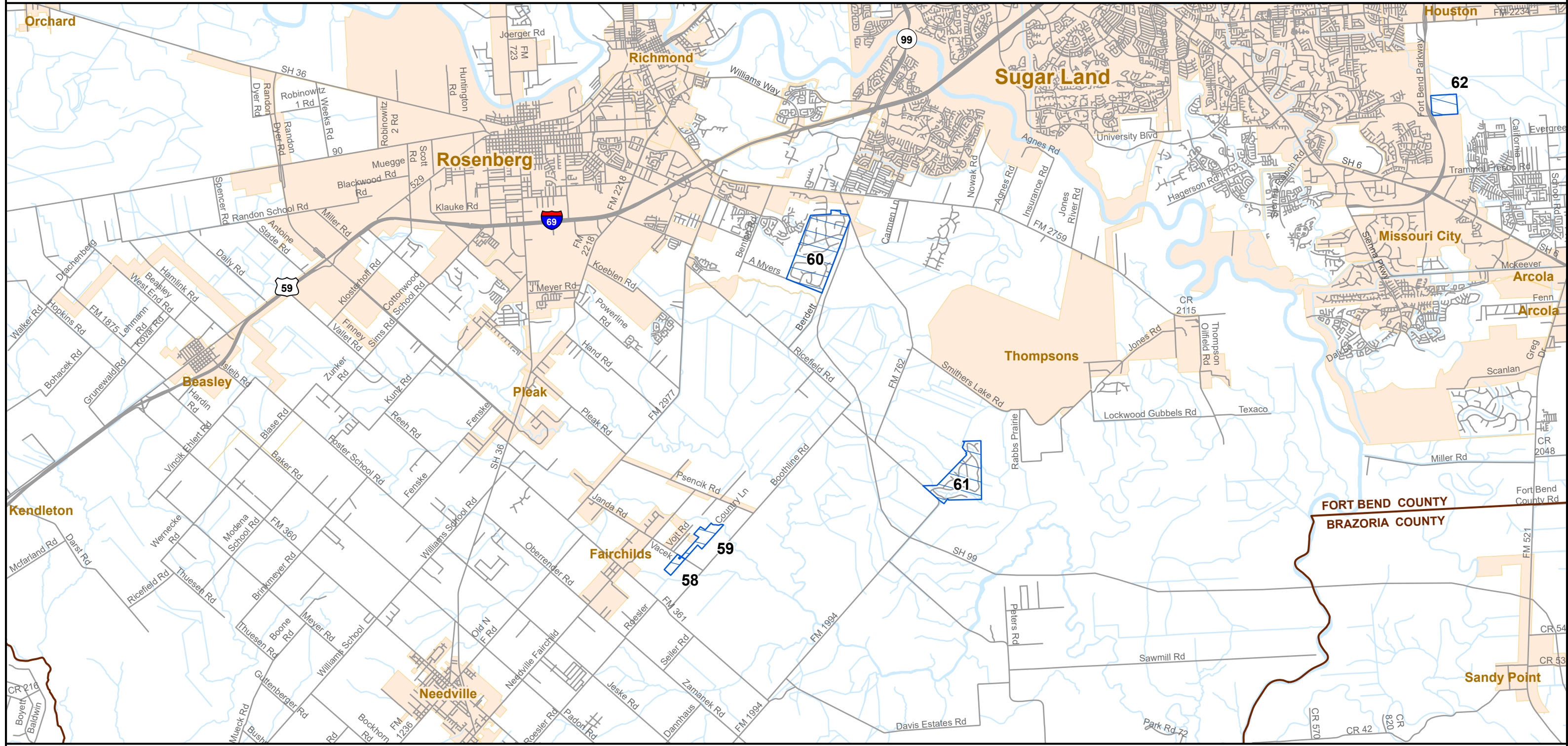

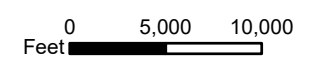

General Location Map #8 - Vacek Pointe, Vacek Country Meadows, Bridlewood Estates, Brazos Lakes and Olympia Falls

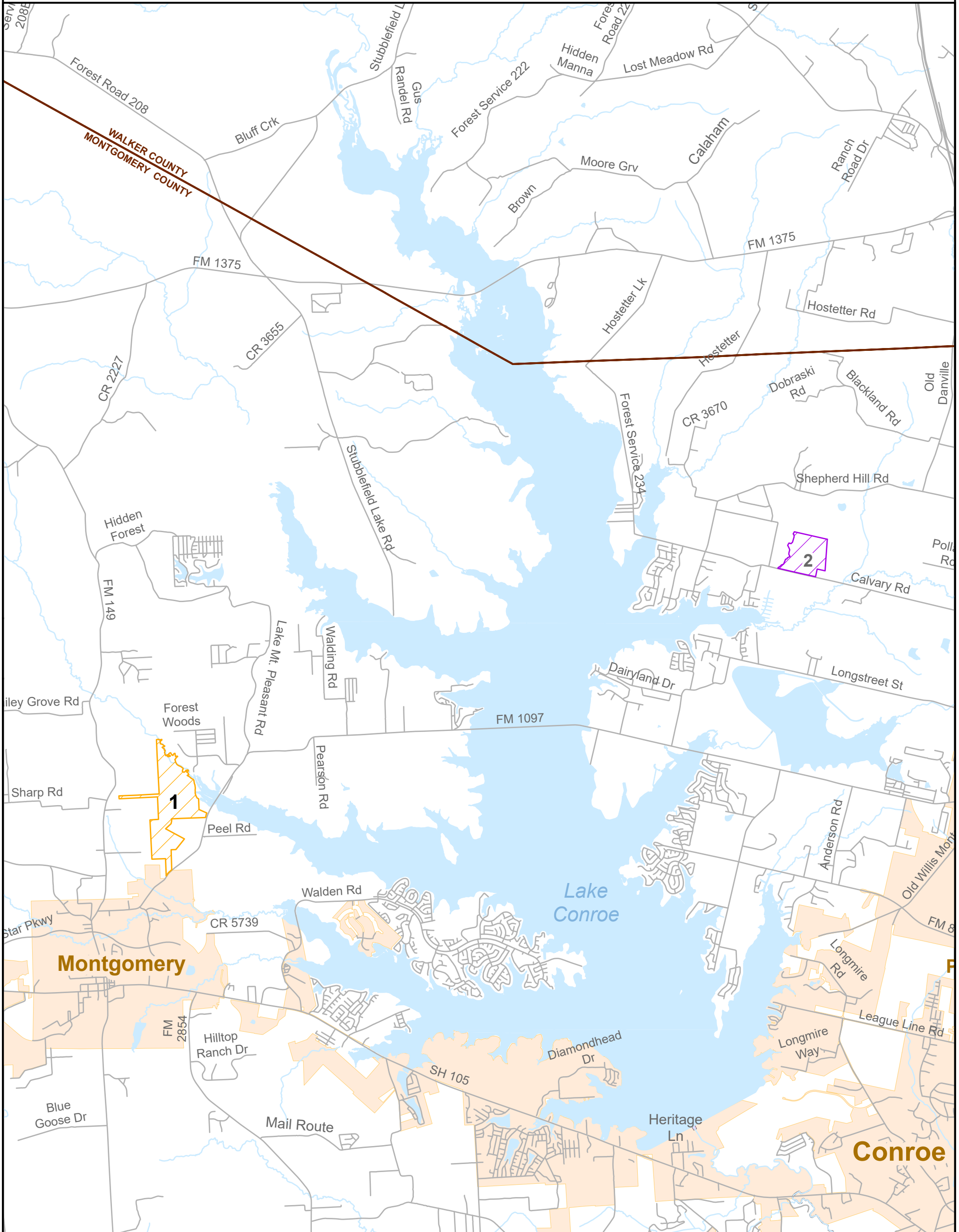

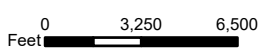

General Location Map #1 - Firesong and Rockrose Ranch

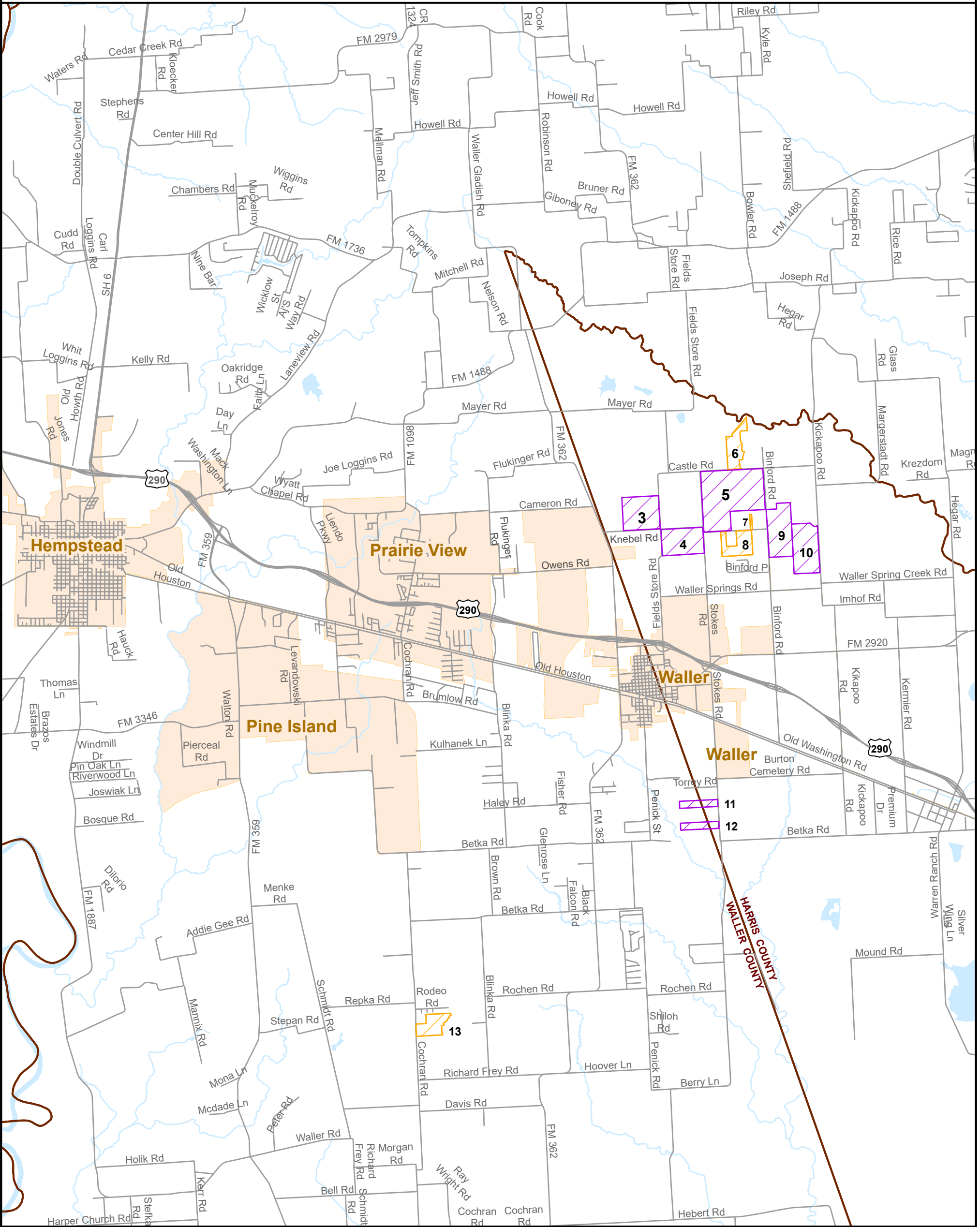

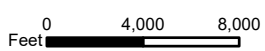

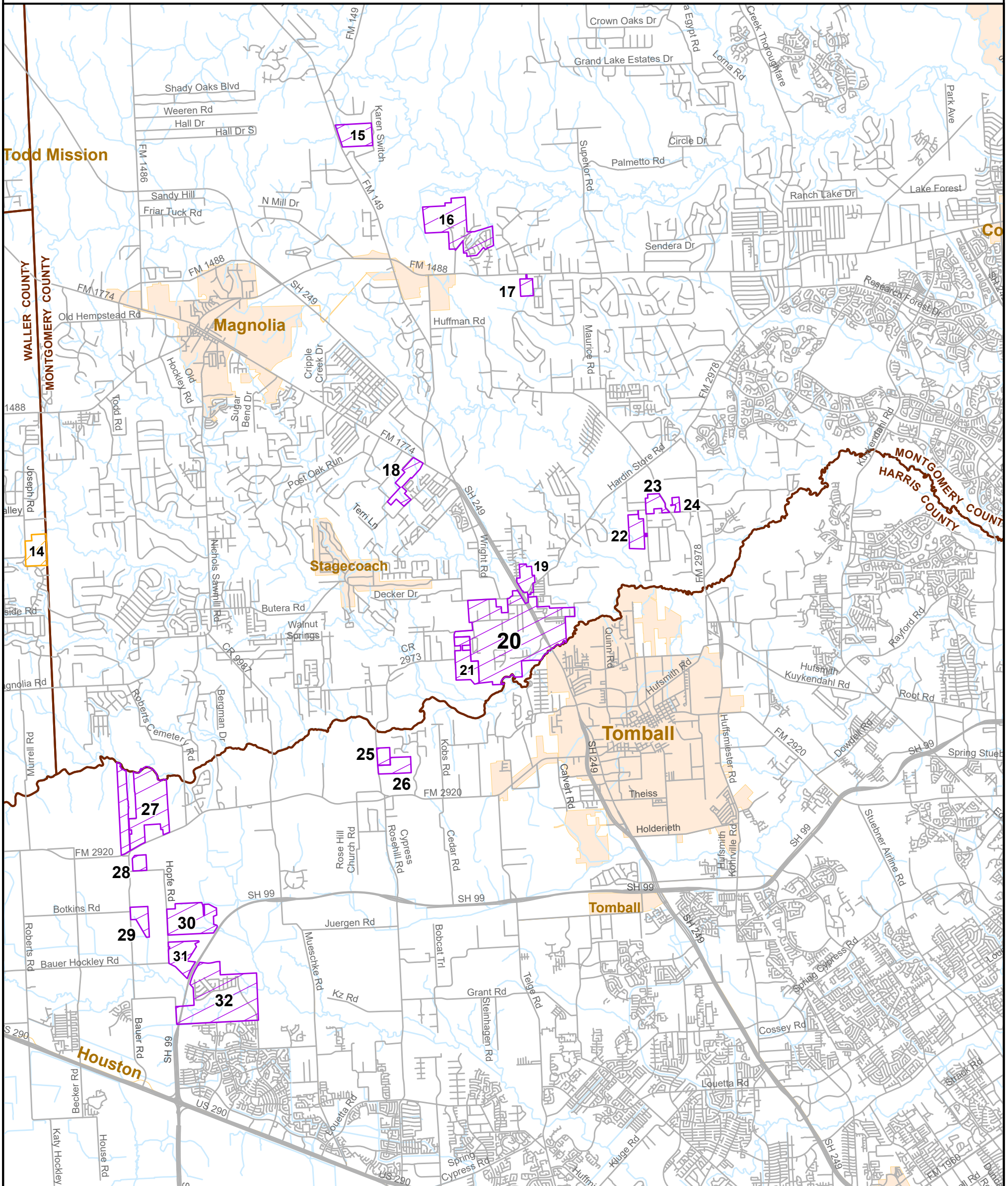

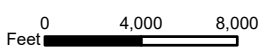

General Location Map #4 - Pine Acre Trails, Sweetwater Ridge, Summerset Estates and Lone Star Ranch

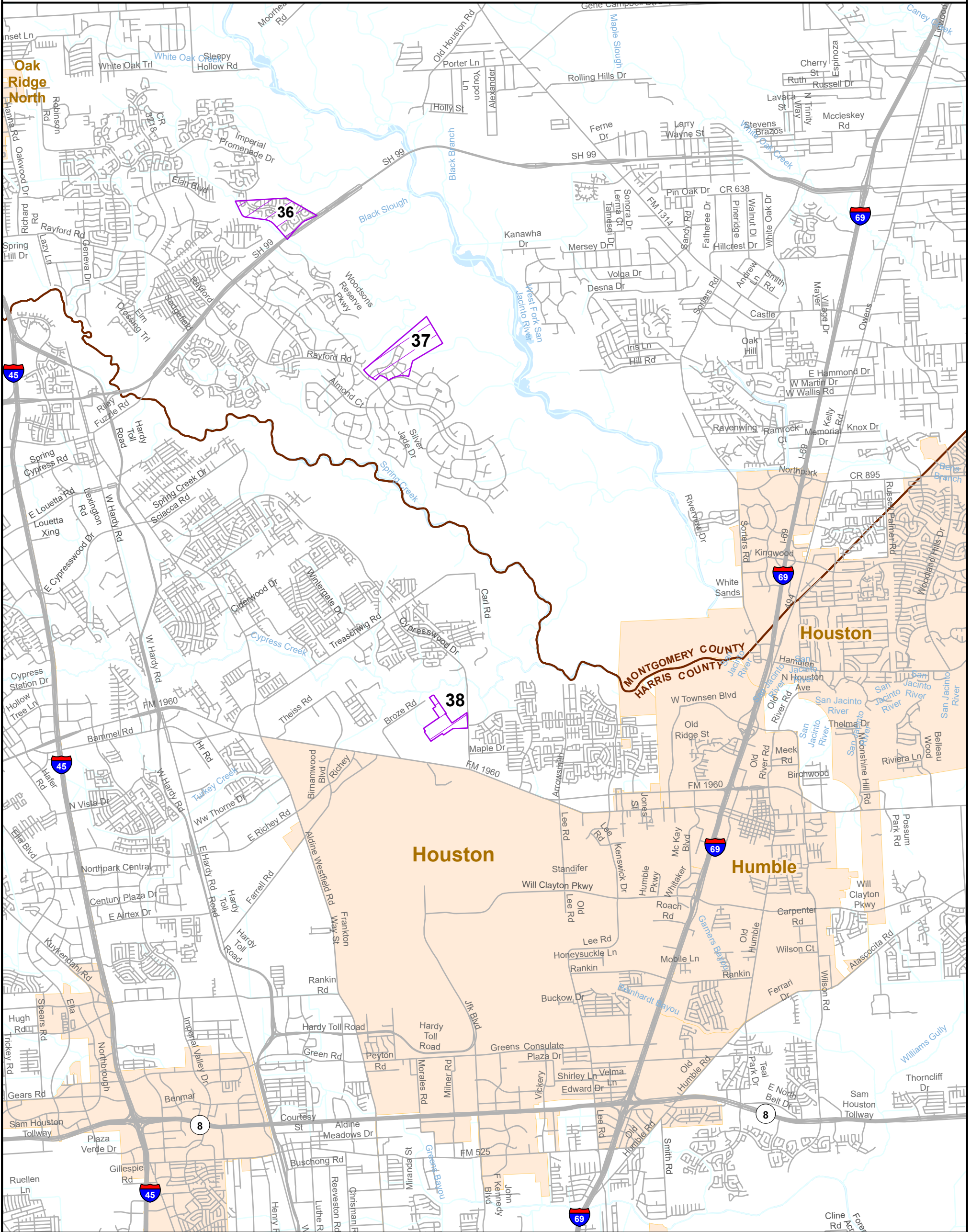

General Location Map #5 - Creekside Village, Benders Landing Estates and Flagstone

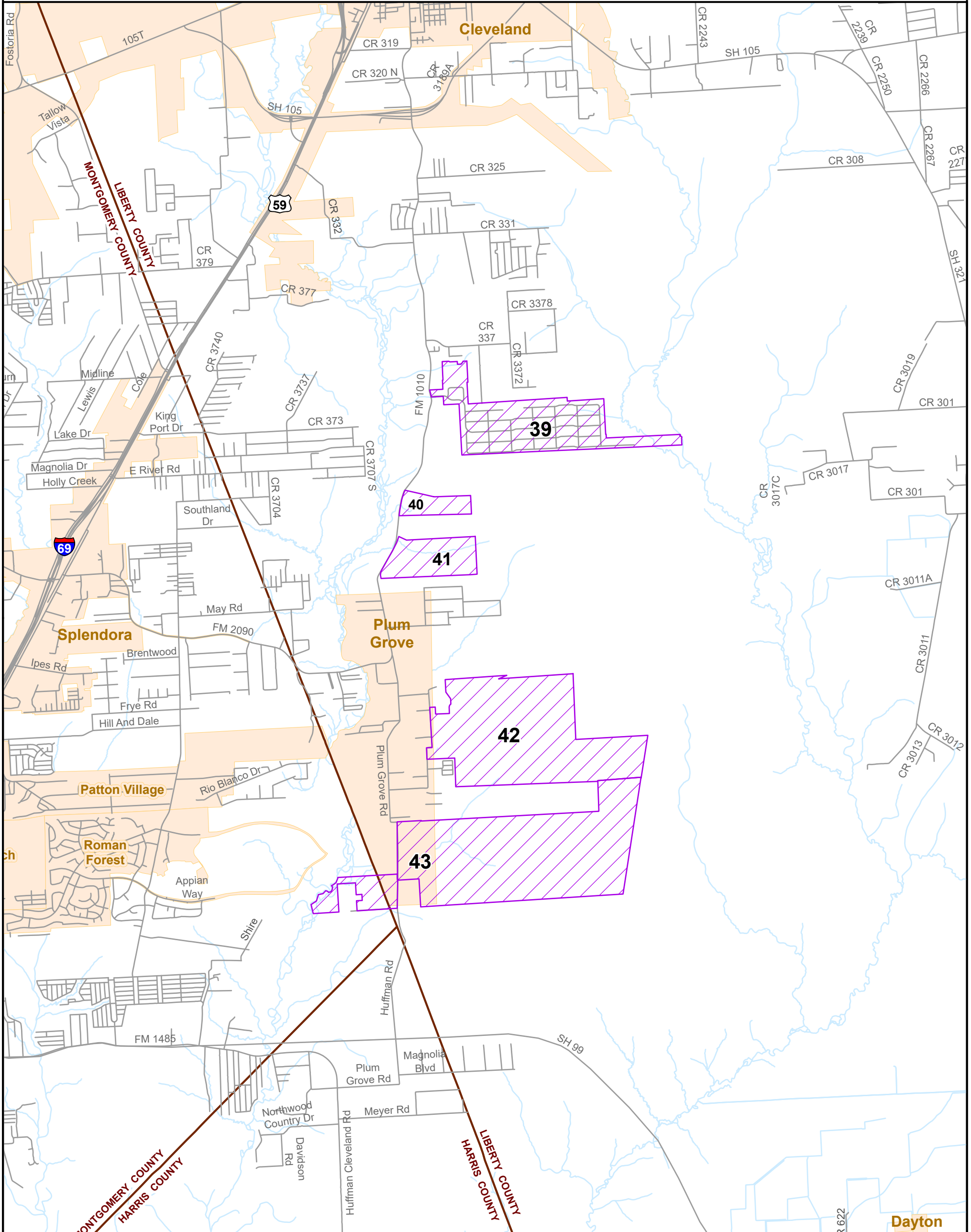

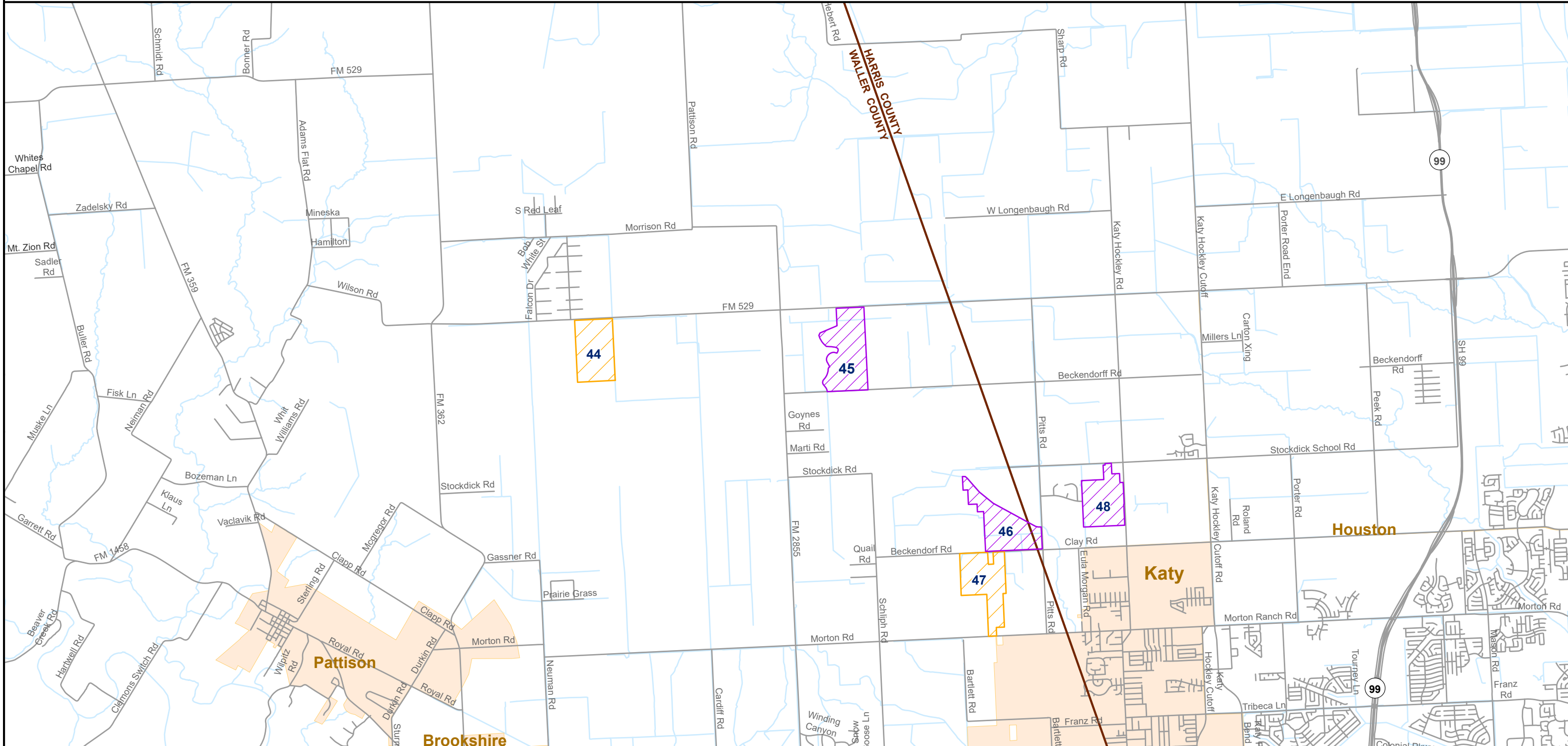

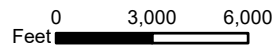

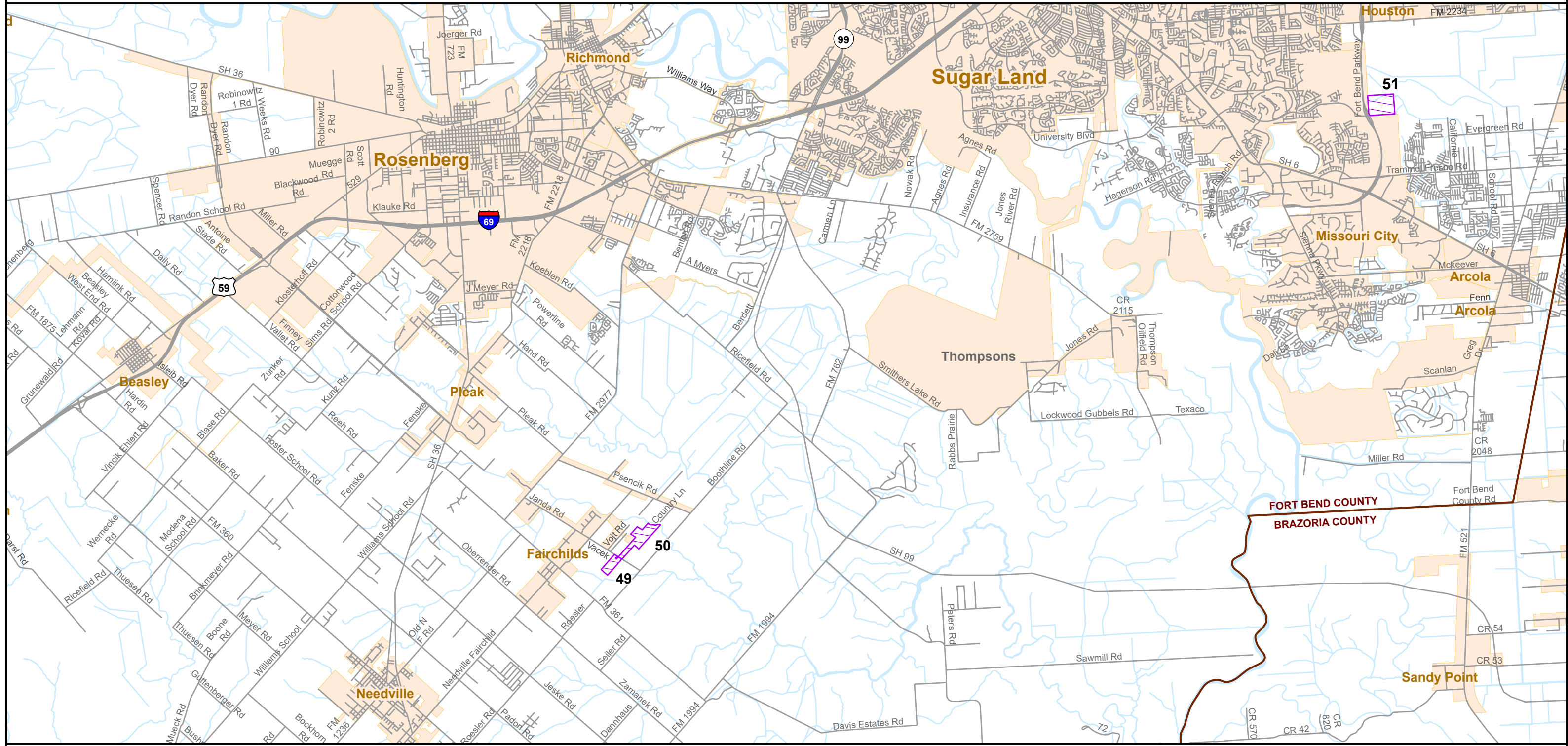

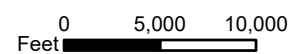
